# **Letter from the President**

For the 2022-2023 campaign season, we asked United Way donors, volunteers, and partner agencies, "Are you all in?" I can't think of a better way to describe our United Way over the last year. We went ALL IN on our commitment to improve the education, income, and health of our community. We began the fiscal year as the United Way of Paducah-McCracken County on the outskirts of a global pandemic and a regional natural disaster. The regional response to the December 2021 tornadoes was the catalyst our board needed to make the decision to expand our geographical boundaries beyond McCracken County. After 88 years of serving Paducah-McCracken County, on September 12, 2022, our board of directors went ALL IN and voted to serve seven counties in western Kentucky.

Following the December 10, 2021 tornadoes, our United Way went ALL IN securing over 1.3 million dollars in grant funds to provide disaster response throughout the region. Those funds have gone directly to relief efforts in the counties of Fulton, Graves, Hickman, and Marshall. This amount is in addition to a \$437,000 American Red Cross grant secured as the fiscal agent for the Mayfield-Graves County Long-Term Recovery Group.

While spearheading disaster relief and expansion efforts, the United Way staff and board members also went ALL IN on their efforts to strengthen outreach programs like Getting Ahead and Bridges Out of Poverty. As a direct result of the connections made through the expansion process, the Bridges programming will be offered throughout western Kentucky.

As the organization embarked on unchartered territories over the last year, our donors continued to give in a way that would allow our partner agencies to maintain their historical funding levels. We are so grateful to our donors who know what it means to go ALL IN for our community. Thank you for your generosity and for joining us and our partner agencies in building a stronger community.

It has been an honor to serve as President of the 2022-2023 United Way of Western Kentucky Board of Directors. We continue to make great strides to improve the lives of those throughout western Kentucky. Together with our donors, volunteers, partner agencies, board of directors, and staff, we will continue to go ALL IN as we learn what it means to truly




